



Statutes of the SnKx Association

Article 1 - Name and seat

It is constituted, among the members of these statutes, a declared de facto association, governed by law and all legislative and regulatory provisions in force in Belgium. Its duration is unlimited and ends in case of dissolution.

The headquarters of the association is located at the secretary's home in Belgium.

It may be transferred by decision of the Board of Directors.

Article 2 - Objectives

The objectives of the SnKx association are as follows:

- Unite sportswear and sneaker enthusiasts within the LGBTQIA+ community.
- Promote cultural, social and sports activities promoting conviviality, inclusivity and sharing among its members.
- Creation of safe and non-judgemental conviviality spaces
- Organize or co-organize events (e.g. parties, meetings, elections) in order to foster social ties and exchanges at the local, national and European levels.
- Raise awareness among members about sexual health issues, risk prevention related to sexual practices, and the use of psychoactive substances, through interventions by specialized actors.
- Fight against discrimination and promote acceptance of the diversity of clothing styles in LGBTQIA+ spaces.
- Implement communication and image promotion initiatives for the association, notably through digital media and events.

Article 3 - Members

The association is composed of active and honorary members.

3.1. Active members:

Any natural or legal person, aged 18 years and over, wishing to become a member must:

- Fill out a membership application.
- Pay the annual fee, the amount of which is set at the General Assembly.
- Adhere to the values and objectives of the association

3.2. Contribution:

The annual fee is set at €10; this one is by calendar year and indivisible.

Applications for membership of active members should be sent to the committee via SnKx's website and the decision on admission is made by the committee.

3.2. Honorary members:

On the proposal of the committee, certain persons may be awarded honorary membership by the general assembly for their particular commitment or for outstanding services rendered to the association; these members are exempt from annual dues.

3.3. Loss of membership

Active membership is lost by resignation, exclusion or following death;

3.4. Resignation and exclusion

The association's exit is possible at any time. The termination must be addressed in writing or by email to the committee without delay. If the exit occurs during the year, the annual fee must be paid in full.

An active member may be excluded, at any time, for the following reasons:

In case of non-payment of the annual fee after 2 written reminders or by email or phone;

- In case of non-compliance with the association's goals and after 2 written warnings;
- In case of voluntary degradation of the association's assets;
- In case of disparagement of the association and/or its goals on social networks, in the press, or any other form of written or verbal communication known to date and future.

In all cases, the founding members committee decides on the exclusion; the member may bring this decision before the general assembly.

Article 4 - General Assembly

The ordinary General Assembly meets at least once a year and is held every year in December or January of the following year.

The invitation to the general meeting, accompanied by the agenda, is sent to the members within 15 days. Sending invitations by email is allowed.

Proposals to be submitted to the general meeting must be sent in writing to the committee within 15 days.

The committee or one-fifth of SnKx members may at any time require the holding of an extraordinary general meeting by specifying the purpose. The meeting must be held within 2 weeks of the request.

The general assembly is vested with the following inalienable tasks and powers:

- approval of the minutes of the last meeting
- approval of the committee's annual report
- receipt of the report on the review and adoption of the annual accounts
- discharge of the committee
- election of the committee president, other committee members and election of the supervisory body
- setting of annual contributions
- adoption or taking note of the annual budget
- decision-making or knowledge-taking regarding the program of activities
- decision-making regarding the committee's proposals and those of the members
- modification of the statutes
- decision concerning the exclusion of members

- decision-making regarding the dissolution of the association and the allocation of any remaining assets.

Any meeting duly convened is capable of validly deliberating regardless of the number of members present.

Decisions shall be taken by a relative majority of the votes cast, without taking into account abstentions and void ballots. In the event of a tie vote, it is the president who has the power to decide.

NB: Simple majority or relative majority: a proposal is accepted when 'yes' wins over 'no'; abstentions are not taken into account in the calculation of the majority.

To be approved, amendments to the statutes require a majority of 2/3 of the votes cast.

The decisions taken shall be recorded, at least, in a record of decisions.

Article 5 - Board of Directors

The association is administered by a Board of Directors of at least three members (President, Treasurer and Vice-President)

The members of the Council are elected for a period of one year and may be re-elected. The Council manages the current affairs and ensures the proper functioning of the association.

The members of the Council at the creation are:

Vice-President: Chris

Treasurer: Cédric

Secretary and Manager partnership : Max

Manager social media : T1 Conor

The combination of functions is possible, except for Presidency & Treasurer.

Article 6 - Right to sign

The association SnKx is committed by the signature of the President.

For expenses and access to bank accounts, the joint signature of the Vice-President and the Treasurer is required.

Article 7 - Resources

The association's resources include:

- Member contributions.
- The revenues generated by the activities and events organized.
- of sales of marketing items in the image of the federation
- Grants and donations.
- All other legal resources.

Article 8 - Dissolution

The dissolution of the association must be decided by the General Assembly according to the procedures defined in these statutes with a 2/3 majority. The remaining assets will be vested in an organisation with similar objectives.
